The office of the Dean, Khyber college of dentistry, Peshawar invites sealed bids for the year 2017-18, under National competitive Bidding from the Income Tax and GST Registered highly reputed National / International eligible firms, manufactures / authorized Sole agents for procuring high quality Equipments & Furniture under regular budget through single stage two envelopes bidding procedure whereas Dental Material, Dental Minor Instruments & Miscellaneous Items under regular budget through single stage one envelope bidding procedure as per rule 6 (2b) of KPK procurement of goods, works and services rules 2014.

Each envelop should contain separately technical and financial bid clearly marked as technical and financial bid in bold and legible letter only for Equipments.

The bidders must be registered with the Director General Health Services Khyber Pakhtunkhwa Peshawar, for the year 2017-18, if the new list of pre-qualified firms is not issued by the Director General Health Services, KPK Peshawar till the opening of Bids, then pre-qualification /post qualification will be made by this Institution.

The quotation shall reach to the undersigned on or before 11-04-2018 at 11:00AM, through registered post, Mail/Courier Services. Which will be opened on the same day at 12:00 Noon, in the office of Medical Director (KTH/KMC/KCD) by the purchase committee in the presence of bidders, who desires.

TERMS & CONDITIONS

01. The rates should be valid upto 30th June 2018.
02. By hand/quotation and hand written tenders will not be accepted, Original brochure will be attached with Bid.
03. Call Deposit must be attached with the tender documents otherwise tender document will not be received.
04. For single stage two envelop system the supplier will attach an affidavit with Technical documents that CDR is attached with financial documents.
05. The successful bidder will supply the local items within 30 days & 90 days for imported items after the receipt of confirm supply order. If the supplier failed to supply the items within stipulated period then 02% penalty will be charged, 05% penalty will be charged for delivery more than 15 days.
06. Income Tax @4.5%, Sales Tax @ 17% and 1% Stamp Duty or as per Government Rules will be deducted from the demand bill of the successful bidder.
07. Standard Bidding Documents & Terms and conditions may be obtained from the office DMS (store), on payment of Rs.1000/- (non-refundable) per set, on any working day in office hours.
08. The supply will be treated canceled if the suppliers supply wrong item or not according to specification.
09. Full particulars with specification, of each item with the country origin should be mentioned with the tender/quotation against each item.
10. The supplier will be responsible for any loss during the transit and will have to replace the damage or lost items.
11. The firm (approved supplier) will be responsible for free service/repair/replacements of spare parts free of cost during the guarantee period which should be mentioned in the quotation and should not be less than one year.
12. The payment will be released on the receipt of complete supply. Security/Call deposit will be released after the expiry of the warranty period.
13. The warranty period will start after installation of equipments in the departments.
14. The Supplier will be responsible for the quarterly Periodic Preventive maintenance (PPM) free of charges till the warranty date.
15. 08% security will be deducted on supply and will be released after warranty period.
16. The Medical Director KTH/KMC/KCD, DEAN KCD/DMS store reserve the right to accept or rejects any tender by assigning reasons.
17. The successful bidder will sign an agreement on Judicial Stamp Paper of Rs.100/- accepting all the terms and conditions mentioned above
