4. It is informed that the approval of aforesaid program(s) shall be subject to the condition that PM&DC Regulations shall be abide by the institution at all times and if any

compromise on standard of education or any violation of PM&DC regulations is noted, the recognition of the program(s) shall be withdrawn. Please also submit the Examination Calendar so that the examinations of the course can be inspected by PM&DC as per rules.

5. It is further informed not to start or make admissions in any course unless it is recognized and notified by the Federal Government under PM&DC Act, 2022. Seat allocation shall be decided by the Council and it shall be binding on the institution to strictly abide by it. An undertaking in this regard is expected to be furnished to the PM&DC inspection team.

6. It is requested to extend full cooperation to the inspection team and supply all such information as may be required by them during the inspection.
